If there is a matter you would like to address with the Board, you must submit a written request to the CVC Director by the first day of the month for review at the next scheduled meeting. If the request is related to a specific claim, it should contain factual information, substantiation, and/or explanation of losses related to the claim.

- The Board has the authority to hold an executive session when considering items protected by the mandatory nondisclosure provisions of the Colorado Open Records Act as allowed in C.R.S. 24-6-402(4)(c), C.R.S. 24-6-402(4)(g), C.R.S. 24-72-202(4)(b)(4), and C.R.S. 24-7-204(1)(a).
